Bids not so made will not be considered. Proposal shall be delivered to Ms. Marie Louise McClure, Treasurer's Office, Village Hall, 1001 Post Road, Scarsdale, New York 10583, on or before 2:00 P.M., Tuesday, February 28, 2012 at which time all bids will be publicly opened and read.

Bidders Qualifications:

Each bidder shall present evidence that they are normally engaged in the type of work bid upon and shall satisfy the Board as to their financial qualifications. They shall make themselves thoroughly familiar with the specifications before submitting their proposal in order that no misunderstanding shall exist in regard to the work to be performed under this contract. No bids will be considered from bidders who are unable to show that they are normally engaged in the type of work on which they are bidding.

Acceptance or Rejection of Bids:

The Board of Trustees of the Village of Scarsdale reserves the right to reject any or all proposals, to omit any item or items, to award Proposal A, Proposal B, Proposal C, Proposal D, Proposal E and Proposal F to the same bidder or **to separate bidders** or in any combination deemed in the best interest of the Village, and to waive any informality in the proposal or to approve minor changes in the specifications if deemed advisable in the interest of the Village.

The Board of Trustees may reject any proposal where there is substantial evidence that the bidder has performed previous work in willful contravention of the terms and conditions of the specifications and contract, and who has delayed such work unnecessarily.

The Board of Trustees reserves the right to reject any bid not accompanied by specified documentation. The Village of Scarsdale reserves the right to reject any bid if it shows any omissions, alterations of form, additions not called for, conditions or qualification, or irregularities of any kind.

Bids to Remain Open:

All bids shall remain open for 45 days after the day of the opening of Bids, but the Village may, in their sole discretion, release any bid and return the bid security prior to that date.

Withdrawal of Bids:

A bidder may withdraw his Bid before the time fixed for the opening of bids by communicating his purpose in writing to the Village. Upon receipt of such written notice, the unopened Bid will be returned to the Bidder.

Refusal to Testify:

Upon the refusal of a person, when called before a grand jury, head of a city department, or other city agency, which is empowered to compel the attendance of witnesses and examine them under oath, to testify in an investigation concerning any transaction or contract had with the state, any political subdivision thereof, a public authority or with any public department, agency or official of the state or of any political subdivision thereof of a public authority, to sign a waiver of immunity against subsequent criminal prosecution or to answer any relevant question concerning such transaction or contract.

(a) such person, and any firm, partnership or corporation of which he is a member, partner, director or officer shall be disqualified from thereafter selling to or submitting bids to or receiving rewards from or entering into any contracts with any municipal corporation or fire district, or any public department, agency or official thereof, for goods, work or services, for a period of five years after such refusal, and to provide also that

(b) any and all contracts made with any municipal corporation or any public department, agency or official thereof on or after July 1, 1959 or with any fire district or any agency or official thereof on or after September 1, 1960, by such person, and by any firm, partnership, or corporation of which he is a member, partner, director or officer may be cancelled or terminated by the municipal corporation or fire district without incurring any penalty or damages on account of such cancellation or termination, but any monies owing by the municipal corporation or fire district for goods delivered or work done prior to the cancellation or termination shall be paid.

Non-Collusive Bidding Certification:

(a) By submission of this bid, each bidder and each person signing on behalf of any bidder certifies, and in the case of a joint bid each party thereto certifies as to its own organization, under penalty of perjury, that to the best of knowledge and belief:

(1) The prices in this bid have been arrived at independently without collusion, consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other bidder or with any competitor;

(2) Unless otherwise required by law, the prices which have been quoted in this bid have not been knowingly disclosed by the bidder and will not knowingly be disclosed by the bidder prior to opening, directly or indirectly, to any other bidder or to any competitor; and

(3) No attempt has been made or will be made by the bidder to induce any other person, partnership or corporation to submit or not to submit a bid for the purpose of restricting competition.

Disqualification of Bidders:

Bids will not be accepted from firms which have pleaded guilty to or, otherwise, been convicted of bid-rigging or related criminal charges. Nor will bids be accepted from firms which include a principal or an officer who has pleaded guilty to or, otherwise, been convicted of bid-rigging or related criminal charges. Such bidders are disqualified from bidding on this project.

Contract Number: For the purpose of identification, the work under this contract will be known as VM Contract # 1126 – Furnish and Deliver Automotive Parts.

General: The contract shall consist of furnishing and delivering all parts, equipment and materials in conformance with the Contract Documentation. All parts, equipment and materials shall be bid as percentage off the manufacturers' list price and/or original equipment manufacturers' list price. **Copies of all manufacturers' list prices and/or original equipment manufacturers' list prices must accompany a submitted bid. Bids received by the Village without the appropriate manufacturers' list prices and/or original equipment manufacturers' list price prices will be considered null and void and the bid will be automatically rejected.** The Village retains the right to not indicate a specified quantity of parts, equipment or materials purchased during the duration of the contract, but the bidder shall guarantee the percentage off manufacturers' list price and original equipment manufacturers' list price, regardless of the quantity ordered during the duration of this contract.

Term: The Contract term shall be for two (2) years from the execution of the Articles of Agreement subject to the availability of the necessary funding for year 2; however the Village reserves the right to award the Contract for one (1) year.

Quality of Bids: Bids are required to be in compliance with the intent of these specifications. Any deviations from these specifications or clarification of item(s) being submitted shall be explained in a **LETTER OF EXCEPTION** attached to the bid.

Place of Delivery: All material shall be delivered to Village of Scarsdale, Central Maintenance Garage, 25 Ramsey Road, Scarsdale, NY 10583.

Delivery: All parts, equipment and materials shall be delivered to the Central Maintenance Garage no later than one business day after the order was processed or as otherwise agreed upon by the Superintendent of Public Works. Parts, equipment and materials not in stock shall be delivered to the Central Maintenance Facility no later than two business days after the initial order. The Village reserves the right to obtain any part, equipment or material ordered the same business day from the bidders' place of work. Any delivery delays must be approved by the Superintendent of Public Works or his designee. Failure to meet these guidelines shall be considered a violation of this contract.

Bid Price Guarantee: Price increases on the manufacturers' price list and original equipment manufacturers' price list will be considered no sooner than six months after the executed date in the Articles of Agreement of this contract and only one increase may take affect during the first year of this contract and if applicable, only one increase may take affect during the second year of this contract. Prior to any increase a new manufacturer price list and/or original equipment manufacturer price list must be submitted for review to the Superintendent of Public Works or his designee, at least two weeks prior to the requested price increase date.

Payment: Prices bid shall be full compensation for all parts, equipment and materials and delivery charges. Payment will be made after submission of executed voucher on form provided by the Village, verification and acceptance of delivery by the Village of Scarsdale and approval by the Board of Trustees.

Material: All material, unless otherwise specified, shall be in conformance with the Detailed Specifications attached hereto and of the best quality available. Contractor shall provide material as required to properly execute VM # 1126.

Rejected Materials and Work: The bidder shall remove from the Central Maintenance Facility, within one business day, all rejected parts, equipment and materials and their failure to do so, or to make satisfactory progress in so doing, within two business days after having been so ordered by the Village of Scarsdale in writing, the rejected parts, equipment or material may be removed by the Village and the cost of such removal shall be taken out of the money that may be due, retained or may become due the said bidder on account of or by virtue of this contract. The bidder shall replace promptly, at their own expense, all materials rejected for failure to comply with the requirements of this contract.

Warranty: The bidder shall warranty all parts, equipment and materials in accordance with the manufactures warranty. All warranties shall accompany the submitted manufacturers' price lists and original equipment manufacturers' price lists.
